



Regulations of the "Wakacje z rowerami cargo" Promotion
valid from July 1, 2020, to August 31, 2020.

I. General conditions.

1. The organizer of the "Wakacje z rowerami cargo" promotion, hereinafter referred to as "**Promotion**", is Nextbike Polska S.A. in restructuring with its registered office in Warsaw, ul. Przasnyska 6b, 01-756 Warsaw, entered into the register of entrepreneurs of the District Court for the Capital City of Warsaw in Warsaw, 12th Economic Division of the National Court Register under the number 0000646950, NIP: 5261029614, REGON: 021336152, hereinafter referred to as "**Operator**" or "Nextbike".
2. The organizer offers the service of renting city bikes in the Otwocki Rower Miejski System, hereinafter referred to as "the Service".
3. The terms and conditions of using the Service are set out in separate Regulations of the Otwocki Rower Miejski System "ORM Terms of Service" available on the website www.otwockirower.pl
4. The terms provided for in the hereby Terms and Conditions of Promotion in capital letters, however, not defined therein, have the meaning assigned to them within the ORM Terms of Service.

II. Rules for using the Promotion.

1. The purpose of the Promotion is to encourage the use of the Service.
2. Promotion is valid only from July 1 to August 31, 2020.
3. The Promotion may be used by any Client who has a Customer Account and meets the other conditions for the use of the Service, specified in the ORM Terms of Service. Moreover, the Promotion may also be used by Clients of other compatible systems, where the operator is a company belonging to Nextbike Capital Group within the meaning of Article 4 point 14 of the Act of 16 February 2007 on competition and consumer protection (Journal of Laws 2020.0.1076), after accepting the ORM Terms of Service.
4. The promotion consists of the fact that during the period indicated in point II. 2. Promotional Regulations The Operator offers Users the possibility of extended use of the Service by providing an additional type of bikes - cargo bikes.
5. **Cargo type bike (family/goods)** - a bike with three wheels behind the torsion chest, whose maximum load cannot exceed 220 kg. It is assumed that the chest's payload amounts to 100 kg, while the burden of a sole driver cannot exceed 120 kg. These bikes are adjusted to carrying up to 4 children in the chest. Renting and returning a cargo bike is possible at each ORM station.
6. Cargo Bike renting in the period indicated in point II. 2. Promotion Regulations is equivalent to taking part in the Promotion.
7. The fees for the use of cargo bikes are calculated according to the rates given in Annex 1 to the Promotion Regulations (Price List), available on the Website, in the Mobile Application, and the Contact Centre. The basis for calculating the fee for using a cargo bike is the Rental Time.
8. The Client may take advantage of the Promotion unlimited number of times in the period specified in point II. 2. Promotion Regulations.



9. The promotion doesn't affect other promotions and fees (e.g. additional fees) that may be possibly due to the Operator from the Client in accordance with the provisions of the ORM Terms of Service and price lists applied by the Operator.
10. The Operator withdraws the option of using cargo bikes as part of the Otwocki Rower Miejski System at the end of the Promotion.

III. Final Provisions

1. For all matters unresolved in the hereby Regulations, including the rules for processing Users' data, the provisions of the ORM Terms of Service shall apply.
2. The Regulations are available free of charge on the Website in such a way to enable familiarizing with the contents, obtaining, reproducing, and recording them. These documents may be obtained at the headquarters of Nextbike Polska S.A. in restructuring.
